Section 4 - Fist Aid Measures

INHALATION: Remove victim to fresh air and keep at rest in a position comfortable for breathing. If it's suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. Section 6 - Spillage/Accidental Release Measures

Personal precautions, protective equipment and emergency procedures:

No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. In the case of aerosols being ruptured, care should be taken due to the rapid escape of the pressurized contents and propellant. If a large number of containers are ruptured, treat as a bulk material spillage according to the instructions in the clean-up section. Do not touch or walk through spilled material. Eliminate all ignition sources. Warning! A motor could be an ignition source and could cause flammable gases or vapors in the spill area to burn or explode. Avoid breathing vapor or mist. Environmental precautions:

Prevent further leakage or spillage if safe to do so. Do not let spilled material or runoff enter drains, sewers, waterways or soil. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).

Methods and materials for containment and cleaning up:

Small Spills: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.

Large Spills: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Contain and collect spillage with non-combustible,

Section 7 - Handling & Storage

Safe Handling Measures: Put on appropriate personal protective equipment (see Section 8). Aerosol cans contain pressurized, flammable propellent. Protect from sunlight, flames and do not expose to temperatures exceeding 50°C. Cans will burst if exposed to extreme heat or temperatures. Do not pierce or burn, even after use. Avoid exposure. Engineering

Controls: Use only with adequate ventilation. The substance irritates the eyes, skin, and respiratory tract. High exposures, above the occupational exposure levels, can cause weakness, headache, and drowsiness and may cause unconsciousness. Irritates the eyes and respiratory tract. Causes central nervous system depression. High levels of exposure may cause fatigue, weakness, confusion, euphoria, dizziness, headache; dilated pupils, lacrimation (discharge of tears); nervousness, muscle fatigue, insomnia; paresthesia; cardiac dysrhythmia, unconsciousness and death may occur. Long Term Exposure

n-Butyl acetate may cause skin allergy. n-Butyl acetate has been shown to damage the developing fetus in animals. Prolonged and repeated exposure to butyl acetates can cause defatting, drying and cracking of the skin. Although many solvents and petroleum based products cause lung, brain and nerve damage, these chemicals have not been adequately evaluated to determine these effects. Repeated or prolonged contact with skin may cause dermatitis; drying, cracking, itching, and skin rash. May cause liver, kidney, and brain damage; decreased learning ability, psychological disorders. Levels below 200 ppm may produce headache, tiredness and nausea. From 200 - 750 ppm symptoms may include insomnia, irritability, dizziness, some loss of memory, cause heart palpitations and loss of coordination. Blood effects and anemia have been reported but are probably due to contamination by benzene. May decrease the fertility in males. Repeated contact can cause drying and cracking of the skin. 
